The International Scientific and Practical Conference «Support and protection of small and medium-sized businesses - the fundamental principle of constitutional economy in the Republic of Kazakhstan» will be held on 25-26 April 2025. It will be a continuation of a similar forum held last October on the need to establish constitutional economics in Kazakhstan as a branch of interdisciplinary research and academic discipline.

The purpose of the conference is to discuss the problems present in Kazakhstan at the beginning of the XXI century on the real implementation of the values of the Basic Law in the economic development of the country; support and strengthening of partnership relations between business and the state; search for solutions to improve the effectiveness of measures of state stimulation of market transformations; strengthening of guarantees and institutions of state protection of small and medium-sized businesses.

The conference will cover the following issues:
the role of small and medium-sized businesses in strengthening a fair, democratic, legal, social and market-oriented state;
measures to stimulate partnership relations between entrepreneurs, the state and society;
unity of rights and obligations in the context of mutual responsibility of business entities and the state (doctrine, practice and law enforcement);
constitutional obligation of public authorities to support and develop small and medium-sized businesses;
responsibility of public authorities in the sphere of protection of business entities;
the role of regional authorities in the field of support and protection of small and medium-sized businesses;
the activity of courts and other state bodies to ensure the rights and legitimate interests of business;
as well as other topical issues.

The discussion will be attended by leading Kazakhstani and international jurists and scholars representing spheres of humanitarian knowledge adjacent to constitutional law. Scientists and practitioners from Moscow, St Petersburg, Baku and other foreign countries have confirmed their participation.



Heads of Supreme Courts of the Republic of Kazakhstan and Azerbaijan, *Deputies of the Parliament and Maslikhats, Representatives of the Government and branch ministries, Akimats* and other executive authorities will share their opinions.

A special role in the conference is given to the *participation of business representatives from various sectors of the economy*: National Chamber of Entrepreneurs «Atameken», lawyers, business lawyers, activists of NGOs practicing in defence of the interests of entrepreneurs.

The conference will result in the publication of a collection of its materials.

The conference organisers - Eurasian Institute of Economic and Law Research, School of Law and Public Administration, School of Economics and Management of Narxoz University, as well as the National Chamber of Entrepreneurs «Atameken» invite you and your employees to take part in this scientific and practical forum.
