The conference will be held on June 13, 2025 in a face-to-face and correspondence format. In the correspondence and online format, the conference will be held on the Zoom platform. Conference schedule: from 10.00 to 17.00.

The main goal of the event: to promote the further development of Chinese-Kazakhstani economic cooperation in current modern conditions, to develop recommendations and proposals for the convergence of the legislation of the People's Republic of China and the Republic of Kazakhstan, as well as to encourage young scientists, scholars and practicing lawyers to conduct scientific research in the field of law.

The following issues are proposed for discussion:

- the Shanghai Cooperation Organization and its development prospects;
- legislation of the People's Republic of China and the Republic of Kazakhstan in the energy sector: ways of rapprochement;
- state regulation of the economy in the People's Republic of China and the Republic of Kazakhstan;
- methods of direct and indirect influence of the state on the economy in the People's Republic of China and the Republic of Kazakhstan;
- investment climate in the People's Republic of China and the Republic of Kazakhstan;
- legislation of the People's Republic of China and the Republic of Kazakhstan on arbitration: main trends of development and improvement;
- rights and obligations of participants in civil circulation in the People's Republic of China and the Republic of Kazakhstan;
- contracts and features of their regulation under the legislation of the People's Republic of China and the Republic of Kazakhstan;
- liability for violation of the legislation of the People's Republic of China and the Republic of Kazakhstan.
